ENTRY REQUIREMENTS

ALL STUDENTS MUST HAVE THE FOLLOWING TO ENTER ANY GWINNETT COUNTY SCHOOL AT THE TIME OF ENROLLMENT.

____ **1. PROOF OF RESIDENCY – PROVIDE ONE OF THE FOLLOWING:**

- A CURRENT UTILITY BILL AND THE SECURITY DEED WITH THE SAME NAME.
- A CURRENT UTILITY BILL AND THE LEASE AGREEMENT SIGNED BY ALL PARTIES WITH THE SAME NAME.
- SALES CONTRACT VALID FOR 30 DAYS ONLY. *****MUST PROVIDE CURRENT UTILITY BILL AND SECURITY DEED AT THE END OF 30 DAYS.*** (NOTE: A CONTINGENCY CONTRACT IS NOT ACCEPTABLE).**

*****NOTE: CURRENT UTILITY BILL MUST BE AN ELECTRIC, GAS OR WATER BILL SHOWING THE OWNER'S NAME AND ADDRESS.*****

____ **2. WITHDRAWAL FORMS FROM PRIOR SCHOOL TO INCLUDE ACADEMIC TRANSCRIPT OF GRADES. ***** AN UPCOMING 9TH GRADER MUST BRING FINAL 8TH GRADE REPORT CARD SHOWING PROMOTION TO 9TH GRADE.*** MUST HAVE AT THE TIME OF YOUR ENROLLMENT. WE WILL NOT SEND FOR RECORDS.*** MUST HAVE THE COMPLETE MAILING ADDRESS OF PRIOR SCHOOL.****

*****AFTER SCHOOL YEAR HAS BEGUN, THE STUDENT MUST ALSO PROVIDE: WITHDRAWAL FORM TO INCLUDE CURRENT WITHDRAWAL GRADES, CLASS SCHEDULE, AND DATE OF WITHDRAWAL.*****

____ **3. GEORGIA STATE LAW REQUIRES ALL DISCIPLINE TRANSCRIPTS. GEORGIA LAW 20-2-670. MUST HAVE AT THE TIME OF YOUR ENROLLMENT.**

____ **4. GEORGIA STATE LAW REQUIRES CERTIFICATE OF IMMUNIZATION FORM. GEORGIA LAW 20-2-771. MUST HAVE AT THE TIME OF ENROLLMENT. IMMUNIZATION RECORDS MUST BE ON GEORGIA FORM 3231. OUT OF STATE FORMS MUST BE TAKEN TO THE GEORGIA HEALTH DEPARTMENT TO BE RECORDED ON GEORGIA FORM 3231.**

____ **5. GEORGIA STATE LAW REQUIRES VISION, HEARING, AND DENTAL CERTIFICATE. REQUIRED FOR ALL STUDENTS ENTERING A GEORGIA PUBLIC SCHOOL FOR THE FIRST TIME. MUST HAVE AT THE TIME OF ENROLLMENT.**

____ **6. PROOF OF LEGAL GUARDIANSHIP – IF THE NAME DIFFERS ON THE PROOF OF RESIDENCY OR THERE IS ANY DOUBT ABOUT GUARDIANSHIP, WE MUST HAVE LEGAL AUTHORIZED COURT PAPERS WITH OFFICIAL NOTARIZATION. WE CANNOT ACCEPT PETITION DOCUMENTATION, BUT WE CAN ACCEPT THE RECEIPT OF PAYMENT TO FILE A PETITION. IF YOU SUBMIT A RECEIPT OF PAYMENT TO FILE A PETITION, WE MUST HAVE FINAL LEGAL AUTHORIZED COURT PAPERS WITHIN 30 DAYS OF ENROLLMENT.**

____ **7. CUSTODY PAPERS OR SIGNED NOTARIZED AFFIDAVIT MUST BE PROVIDED IF STUDENT RESIDES WITH ONE NATURAL PARENT.**

____ **8. ANY STUDENT UNDER 18 YEARS OLD MUST BE ACCOMPANIED BY THE PARENT OR GUARDIAN.**

____ **9. SOCIAL SECURITY NUMBER REQUESTED FOR HOPE SCHOLARSHIP FUNDING.**

*****SPECIAL NOTE: IF YOU ARE LIVING WITH A FRIEND OR RELATIVE YOU MUST SEE THE GUIDANCE OFFICE FOR ADDITIONAL ENROLLMENT FORMS. THESE FORMS MUST BE REVIEWED AND APPROVED BY AN ASSISTANT PRINCIPAL BEFORE ENROLLMENT CAN TAKE PLACE.*****
